Children have support plans in place and progress has been made from their starting points in all areas. The support plans are shared with parents, so they fully understand what their children are learning and are able to reinforce this at home.

Pupil premium children have the option to attend one after school club each half term, breakfast club and have fully participated in all school trips. Breakfast club enables the children to have nutritious breakfast, social time with their peers and some focussed adult attention at the start of the day. After school clubs provide a variety of sporting experiences and funded school trips supports full inclusion in all learning experiences.

Additional resources such as school uniform and other equipment were provided throughout the year. This allows all children to fully enjoy school life along with their peers, resulting in strong wellbeing and school community involvement.

Attendance was closely tracked and a strong relationship between family and home established. Support for attendance was given by school when necessary.
